

PUPPY CONTRACT

The following agreement is between Memory Farm Aussies, hereafter referred to as "Breeder," and _____, hereafter referred to as "Buyer," for the sale and purchase of one purebred Miniature Australian Shepherd.

No Verbal agreements will be entered into.

Will become property of the buyer upon fulfillment of the following conditions.

Purchase Price

1. Purchase price of \$_____ paid by the Buyer to the Breeder.

After a nonrefundable deposit of \$250 is paid puppy will be held until (date) _____. At that time the balance of the purchase price \$_____ must be paid in full, or the deposit is forfeited and alternate arrangements will be made for placement of the puppy.

Transportation

2. All transportation costs will be paid by the Buyer. Transportation costs include: shipping container, airport delivery charge, and any expenses involved in the shipping of the puppy must be prepaid before the puppy is shipped. Freight charges including full insurance are approximately \$_____. At buyers request Memory Farm will meet buyer with puppy for hand delivery. A distance of up to 250 miles will be included in purchase price of puppy. Distances over 250 miles will incur a \$0.30 a mile charge. EX: 500 miles would be a charge of \$75.00 to buyer.

Other agreements between Buyer and Breeder

3. The Breeder guarantees that the puppy is in good health on the date of delivery. Breeder guarantees that the dog is healthy and free of known contagious diseases and has had vaccination(s) and worming required for its age at the time of agreement.

4. The Buyer agrees to have the dog examined by a licensed veterinarian within 48-72 hours of receipt of the puppy. If the dog is determined to be in poor health, as evidenced by a veterinarian's written statement, the Buyer can elect to keep the dog, assuming all costs for its care, or may return the dog for a full refund (less transportation costs) upon the Breeder's receipt of the veterinarian's statement regarding the dog's health. This provision expires 72 hours after the Buyer takes possession of the dog.

5. The Buyer shall maintain the puppy in good condition, including adherence to a regular schedule of heartworm preventive, regular deworming schedule, vaccinations, and maintain puppy on a diet of approved dog food.

6. If at any time in its life the puppy is to be sold or given away, the Buyer shall so notify the Breeder and give the Breeder first option to buy the puppy back at the original purchase price.

7. Buyer certifies, by signing this agreement that he/she is not acting as an agent in this purchase; that the Buyer will not resell this puppy to a pet store, guard dog business or medical research facility.
